Submission Checklist

Note: We cannot process your application unless all of the following documents are submitted.

___ Mortgage Pre-qualification Letter: Please include a letter from your bank or a mortgage lender that indicates you qualify for a mortgage.

___ Status in Canada: For each home owner, attach copies of birth certificate, citizenship document, Native Status card, permanent resident card, record of landing, convention refugee documentation, and/or refugee claimant form.

___ Photo Identification (ID): For each home owner, attach a photocopy of one piece of photo ID (e.g. driver's licence, passport).

___ Proof of Living in the County: Attach copies of your rent receipts, utility bills, etc. for the last 6 months or a copy of your lease for your current rental in the County of Oxford.

___ Bank Verification Form (Appendix B) & Bank Statements: For each household member 16 years of age or older (excluding dependent full-time students living at home), provide details regarding sources and amount of all assets. The Bank Verification form must be completed and signed by any bank, trust company or credit union where you have an account, and 6 months worth of recent bank statements shall be provided for each applicant.

___ Employment Verification: For each household member 16 years of age or older (excluding dependent full-time students living at home), please attach a letter from your employer verifying your income and length of employment.

___ Income and Assets (see Appendix A): For each household member 16 years of age or older (excluding dependent full-time students living at home), attach copies verifying sources and amount of all income, as well as information about your assets. Total value of household assets must be approximately less than \$40,000 (Section 5 in application form).

___ Notice of Assessment: For each household member 16 years of age or older (excluding dependent full-time students living at home), attach a copy of your most recent Notice of Assessment from Canada Revenue Agency.

___ Arrears (if applicable): If you have previously lived in Community (subsidized) Housing and owe money to the landlord, attach a copy of the repayment plan.

___ Agreement of Purchase and Sale (if available): You must enter into an Agreement of Purchase and Sale within 90 days from the date of the Conditional Letter of Commitment and submit a copy to the County upon signing. Funds are then made available to your lawyer for closing.
