The County of Oxford Land Division Committee has received Applications for Consent.

Purpose and Effect of Applications for Consent:

The applications for consent propose the severance of approximately 288.7 m² (3,107.6 ft²) from the subject lands, to be added to the parcel to the immediate north. It is proposed that the lot to be severed will have approximately 6.2 m (20.4 ft) of frontage on King Street East and a depth of approximately 45.8 m (150.5 ft). The lot to be severed contains an existing driveway access.

It is proposed that the lot to be retained will be approximately 649.1 m² (6,987 ft²) in size with approximately 21.4 m (70.2 ft) of frontage on King Street East and an approximate depth of 43.4 m (142.4 ft). The lot to be retained contains three apartment dwelling units and no new development is proposed for the retained lands.

The lot to be enlarged is currently 599.3 m² (6,451 ft²) in size, with no frontage. The lot to be enlarged is currently vacant and two new semi-detached dwelling units and one basement dwelling unit (for a total of three dwelling units) are proposed for the enlarged lot.

An easement has also been requested over the lot to be severed, in favour of the lot to be retained to allow for continued driveway access and access to the existing parking area serving the retained lands. An additional easement over Part 22 Plan 41R-8526 on the retained lands has also been requested, in favour of the lots to be severed and enlarged to allow for additional access for the future residential development on the lot to be enlarged.

The subject lands are described as Part Lot 4D, 5D, Block 43, Plan 279 in the Town of Ingersoll. The subject lands are located on the north side of King Street East, lying between Mill Street and Carroll Street and are municipally known as 65 and 67 King Street East in the Town of Ingersoll.

Only the applicant, the Minister, a specified person or any public body may appeal decisions in respect of applications for consent to the Ontario Land Tribunal.

If the entities eligible to make an appeal of a decision of the Land Division Committee in respect of the proposed Consent do not provide written submissions or make oral submissions at a public meeting before the Land Division Committee gives or refuses to give a provisional consent, the Ontario Land Tribunal may dismiss all or part of the appeal.

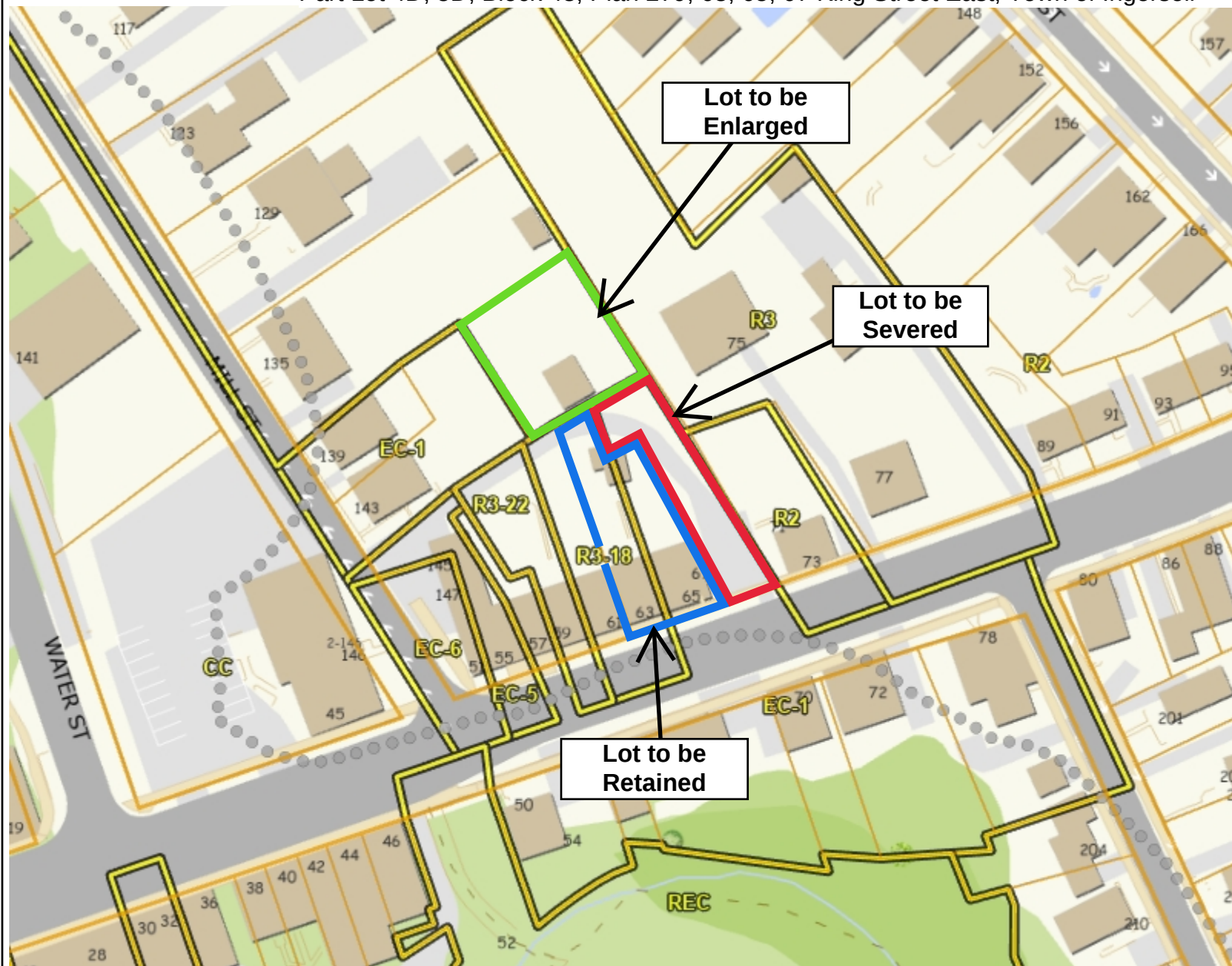

Part Lot 4D, 5D, Block 43, Plan 279, 63, 65, 67 King Street East, Town of Ingersoll



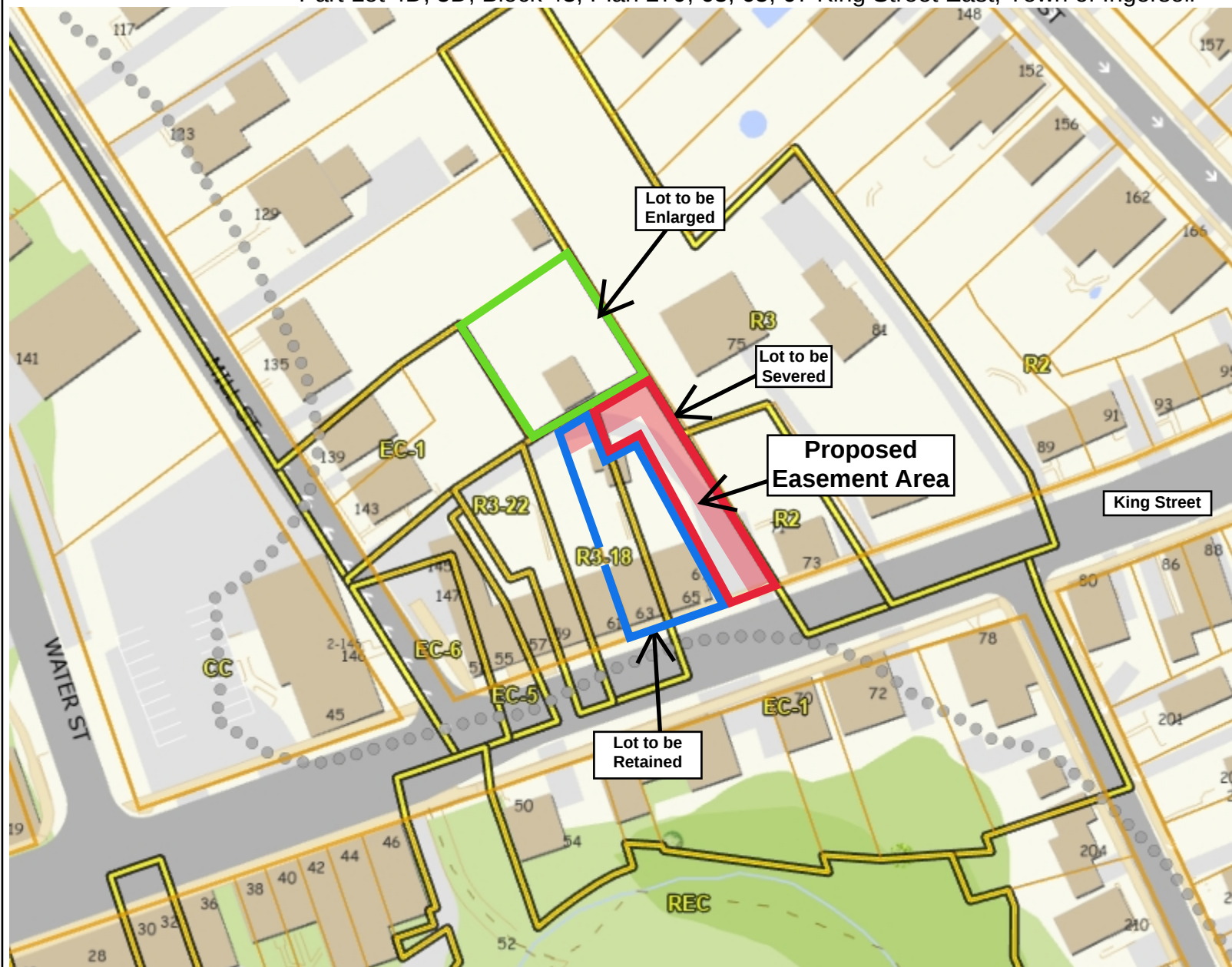
